GLENDALE HOOVER NABS SOUTHERN C.I.F. CROWN

OXNARD, May 17.—Led by the sterling efforts of two Tornado speedsters, the Glendale Hoover High spikemen sweated out a 24½-to-24 victory over the defending Southern California champions, Redondo, this afternoon to capture their second Southern California team title in three years.

John Bradley of the Tornadoes raced to a 9.7s. win in the century and 21.1s. victory in the furlong, both times with a slight breeze at his back.

Bradley's teammate, Sam Nicholson, captured second in the 180 lows behind Dixon of Redondo who turned in 19.2s on the wind-swept track. Nicholson

also hooked second in the broad jump, won by Smith of San Diego High with a 22ft. 6¼in leap.

The Redondo High Seahawks reversed a week-old decision over the Tornado half-mile relay team with a 1m. 29.8s. clocking. Redondo's other first spot came from Jack Norgren's 50s. effort when he won over the field with a good amount of daylight showing in the 440.

Beverly Hills copped the B title over Mark Keppel, 17 to 14, while the C division saw a two-way tie for first between Santa Barbara and Alhambra.

MINUTES OF THE EXECUTIVE COMMITTEE MEETING MARCH 20, 1947

The Executive Committee met in the C.I.F., Southern Section Office Thursday, March 20 at 3:30 P.M. Those present were: Mr. Kinter Hamilton, President; Mr. Normal Hayhurst, Mr. A. E. Konold, Mr. Seth F. Van Patten, Secretary; Mr. Arthur Badenoch, President of the Council, Brother Edwin, Vice-President of the Council; and Mr. Roland Davis, Director of Physical Education Woodrow Wilson High School.

Santa Barbara Track Athletes

The Council at its meeting on February 1, 1947, directed Santa Barbara High School to send boys to the Ventura League Meet to qualify for the Divisional Meet.

The Ventura League protested this action by the Council. Their contention was that the presence of athletes in the league meet who were not members of the league would detract from the glamour of the league which is the high light of the league track season.

Two alternatives were discussed by the Committee:

(1) That Santa Barbara arrange a dual or a triangular meet with some of the larger schools and that it be a qualifying meet for Santa Barbara boys.

(2) That the Executive Committee send timers and judges to Santa Barbara on a set day to time and judge Santa Barbara's boys and that the Santa Barbara boys must do as well or better than the third place boy in the Pacific League meet to qualify for the divisional meet.

The Commissioner of Athletics was directed to work with Santa Barbara High School in carrying out one of these plans.

Team Tennis Regulations

Mr. Roland Davis of the Woodrow Wilson High School discussed the team tennis regulations now in vogue among the leagues. He stated that it was often difficult to arrange a match outside his own league due to differences in league regulations. He discussed at length the philosophy of team tennis. There being no objection, the chairman directed Mr. Davis to put his recommendations in written form and submit them to Mr. Van Patten for publication in our Monthly Bulletin. It was agreed to bring the recommendations up before the Council at its May meeting.

Midland School

Mr. Van Patten presented a letter from Midland School at Los Olivos in Santa Barbara County asking to be admitted to the C.I.F., Southern Section. It was moved by Mr. Hayhurst, seconded by Mr. Konold that the request be granted and the school admitted on a free lance basis. Carried.

California Junior Republic

Because the California Junior Republic is an Institution supported mainly by the Community Chest, Mr. Hayhurst moved that enough money be appropriated from the general fund of the C.I.F., Southern Section to pay their annual dues. Mr. Konold seconded the motion and it carried. **Rule (2), Article XIII, Page 24 of 1945 Blue Book**

A letter was presented to the Executive Committee from Mr. L. Frank Kellogg, Vice-Principal of the Anaheim High School citing certain objections to rule (2), Article XIII, page 24, of our 1945 Blue Book. It was pointed out by Mr. Hamilton that this rule was enacted to prevent a Class B boy from playing Class B football on Thursday and then substituting in a Class A game on Friday of the same week. This was not an uncommon practice prior to enactment of the rule. The rule has done what it was planned for it to do. It has corrected the above evil.

There being no objection, the Chairman directed the Secretary to write to Mr. Kellogg inviting him to the next meeting of the Executive Committee in order to discuss any needed change in the rule.

Basketball Tournament Suggestion

A letter was presented from Lee Mosteller, basketball coach at the Huntington Beach High School recommending that at the close of each basketball season we hold a basketball tournament in which all of the schools of the C.I.F., Southern Section might take part if they wished to do so. He gave as reason for this change that at the end of the basketball league season the league winner is not always the best team in the league. He gave as another reason the great thrill all players get from tournament play.

It was the opinion of the members of the Executive Committee that a tournament including all teams of the C.I.F., Southern Section would prolong the basketball season so much that other spring sports would be handicapped.

Council Expenses

A question of how much expense should be paid to Council Members who attend Council

meeting was raised. It was moved by Mr. Konold, and seconded by Mr. Hayhurst that only transportation expenses be paid. Carried.

Contests With Los Angeles City

At the Council meeting of February 1, Mr. Van Patten was instructed to negotiate with the L. A. City Section of the C.I.F. looking to the arrangement of inter-sectional contests between champions of the L. A. City Section and the C.I.F., Southern Section. Mr. Van Patten reported that he had met with a committee from the L. A. City Schools and a tentative plan had been agreed upon which would lead to contests in gymnastics, swimming, tennis, golf, and baseball. He reported also that the athletic committee of the Los Angeles schools had approved the proposals.

It was moved by Mr. Badenoch and seconded by Mr. Hayhurst that the report be approved and the arrangements of further details be left to Mr. Van Patten. Carried.

Mr. Van Patten reported also that the L. A. City men were anxious to arrange a football contest for next football season.

There being no objections, the Chairman directed Mr. Van Patten to arrange for a joint meeting between the Executive Committee of the C.I.F., Southern Section and the Athletic Commission of the L. A. City Schools to review the problem.

L. A. County Recreation Department Field Day
Mr. Van Patten reported that the L. A. County Recreation Department was staging a track and field meet at the Los Angeles Coliseum on April 3 and 5. He said he had told schools of the C.I.F., Southern Section that the only way their boys may compete is as unattached athletes. He said he had notified them also that they must not be identified in any way with the playground teams. These rulings were approved by the Executive Committee.

It was the unanimous opinion of the members of the Executive Committee that our high school athletes should not enter meets of this character. High school boys who compete for their schools

have competition enough. Playground competition should be left to boys who cannot represent their high schools.

Passing Means Receiving Credit

The Citrus High School asked the C.I.F. Office for a ruling on a boy who had been in school the last twelve weeks of last semester and who had gotten a passing grade for the twelve weeks but had not been given a semester's credit toward graduation.

Mr. Van Patten reported that he had given it as his opinion that the boy was ineligible for competition because he had not received any credits toward graduation for the work done last semester. He held that "passed" as used in rule (e), page 14, was synonymous with "received credit." The question was discussed carefully. There being no dissenting opinion, the Chairman ruled the opinion given by Mr. Van Patten sustained.

No Rule But "No Can Do"

A boy whose league has no spring football practice had asked the Pasadena Junior College to be allowed to practice football this spring with the college men. We have in the C.I.F., Southern Section no rule which covers this specific case. The Executive Committee were unanimous in the opinion that the spirit of rule (2), Article VI, page 16 of our 1945 Blue Book, would be violated if a boy who expects to play high school football next season were to practice this spring with a college team. The chairman announced that the Executive Committee would ask the Council to declare a boy ineligible for high school competition under the conditions set forth above.

Order of Events in Final Track Meet

Mr. Davis and Mr. Badenoch presented the order of track events as they are run in the Pacific League and the Bay League. The orders given below have some advantages over the order followed by the C.I.F., Southern Section. In both cases the high hurdles can be put on the track before the meet starts. If two straightaways are available, the low hurdles may be set up before the start of the meet too.

The practicability of changing the order of events in the final meets will be discussed at the next Council Meeting.

Division Meet Regulations

Mr. Van Patten submitted the following points of importance regarding qualifying boys for the final meets.

The Executive Committee directed that these facts be published in the Monthly Bulletin and that copies be posted on school bulletin boards and that they be supplied to the leading officials at the divisional meets.

C.I.F., SOUTHERN SECTION TRACK RULES

Who May Compete in Divisional Meets

Each of the nineteen leagues in the C.I.F., Southern Section may qualify three (3) boys for each event on the track and field program. Free lance schools may compete in some qualifying meet approved by the Commissioner of Athletics.

Who Qualifies for the Final Meet

TRACK EVENTS: In the sprints and hurdles, the winner in each of the five divisional meets qualifies for the final meet. Three others are chosen for sprints and hurdles on the basis of the time made in the divisional meets. For all other races, eight boys are chosen on the basis of time made in the divisional meets. In the relays only seven teams will be chosen for the finals.

FIELD EVENTS: Eight boys are chosen in each event for the finals on the basis of height or distance made in the divisional meets.

Very Important

Every boy who gets into the finals, except the winners in the sprints and the hurdles, gets his chance in the finals on the basis of what he does in the divisional meet. Eight boys will be chosen in each event to compete in the finals by the track committee. They will be chosen on the records made in the divisional meets. In the relays only seven teams will be chosen for the finals.

THE COACH SHOULD BE VERY CERTAIN THAT HIS BOYS UNDERSTAND THAT IN THE DIVISIONAL MEET THEY ARE COMPETING AGAINST ALL THE BOYS OF SOUTHERN CALIFORNIA.

For Example: A boy at the San Diego Division Meet is winning easily in the 440 yard race. There may be eight other boys in Southern California whose time is better than the winning time of the San Diego race. The San Diego boy should give his all to make sure that he will be among the first eight.

IN THE HIGH JUMP AND POLE VAULT WHEN A BOY HAS WON EITHER OF THESE EVENTS IN THE DIVISIONAL MEET, HE MUST CONTINUE UNTIL HE IS ELIMINATED AS HE IS COMPETING AGAINST BOYS IN THE OTHER FOUR DIVISIONAL MEETS.

Ties for Places

Wherever ties in time, height, or distance qualify more men than the number authorized, the men tied are to qualify for the place on the Tuesday preceding the finals or forfeit their right to the place.

Class B and Class C Tennis

An Entry Blank for the Class B and Class C Tennis Championship is enclosed with this Bulletin. They must be returned to the C.I.F. Office by Wednesday, April 9.

Gymnastic Meet

The gymnastics championship meet will be held at the Beverly Hills High School on Saturday, May 3. The preliminaries will be held at 2:00 P.M. The finals will be held in the evening starting at 7:30 P.M. Entry blanks will be sent to all schools April 21.

Orange League Sportsmanship

Each year the Orange League awards a permanent trophy to the school displaying the best sportsmanship for the combined football and basketball season. Three students and one faculty member of the opposing school act as judges using the following rules:

- (1) No encouraging enmity between players.
- (2) Cooperation with yell leaders.
- (3) No leaving the bleachers and going on the playing field.
- (4) No roughhousing in the sands.
- (5) No throwing of missiles in the stands.
- (6) No drowning out of opponents yells or songs.
- (7) No invading of opponents bleachers.
- (8) No razzing of officials, players, or individuals.

At the end of the season the faculty representatives who act as judges get together and tabulate the score for the season and make the award. Valencia High School of Placentia, was presented with this trophy on February 27 at a league meeting. They have reason to be proud of this achievement. Congratulations Valencia.

Sanctioned Events

All schools are reminded that no athletic event is open for competition to boys from our high schools unless it is sponsored by one of our member schools and sanctioned by this office.

We have no control over Colleges, Junior Colleges, 20-30 Clubs, Junior Chamber of Commerce etc. and boys from our schools may not compete in activities that are managed by such organizations unless some one of our member schools acts as sponsor.

Activities open to the schools of a single league and sponsored by one of our member schools need no sanction.

Inter league activities must be approved by the C.I.F., Southern Section Office. The C.I.F. Office is responsible for seeing that special activities do not interfere with each other.

PROPOSED PLAN FOR TENNIS TEAM PLAY IN ALL LEAGUES OF THE C.I.F., SOUTHERN SECTION

- Each Coach is professionally obligated to play his players in positions directly related to their ability as indicated by "Continuous Single Ladder" play throughout the season of sport. (February 15 to June 15).
- Teams are to consist of nine players
- The "First Doubles" team must be chosen from within the first five players on the continuous ladder
- The "Second Doubles" team must be composed of players whose number ratings on the ladder when added together are **not less** than the sum of the numbers of the "First Doubles" team
- The team scoring is as follows:

- Matches are **not to be forfeited**. The absence of a player or players on the day of a match is handled by substituting the **next player** below his rating and **elevating each other**

player below until each match is qualified to be played on the same basis as stated in No. 1, No. 3, and No. 4.

- In all competitive sports the Coach is expected to field the best team of eligible contestants that he has at his disposal on that day.

Note:

A careful check of the scoring plan will indicate that it is necessary for at least five (more than half) of the players to win their matches in order to win the team match. This eliminates the "jockeying process," as the strength of the team must be played at the top in order to win.

All cross country meet managers have learned that one of the biggest problems is to pick finishing competitors in the proper order. If there are a great many entries, it is necessary to have a chute roped off to assist the checkers and finish judges.

GLENDALE HOOVER NABS SOUTHERN C.I.F. CROWN

OXNARD, May 17.—Led by the sterling efforts of two Tornado speedsters, the Glendale Hoover High splkemen sweated out a 24½-to-24 victory over the defending Southern California champions, Redondo, this afternoon to capture their second Southern California team title in three years.

COUNCIL MEETING

February 1, 1947

The C. I. F., Southern Section Council met in the Board of Education Room, Compton College on Saturday, February 1, 1947. The meeting was called to order by the President, Mr. Arthur H. Badenoch at 10:00 A. M. The roll was called.

A quorum being present, the meeting proceeded as scheduled.

Mr. Berlin moved that the minutes of the last Council Meeting be approved as printed in the bulletin. Mr. Donald McIntosh seconded the motion and it was carried.

Financial Report

The Commissioner of Athletics made an incomplete financial report.

Dr. Thompson moved that the financial report be filed. Mr. S. Chester McIntosh seconded the motion and it was carried.

Surplus

The Executive Committee's recommendations as to the use of surplus funds was given. Mr. Harry Moore moved that the C. I. F., S. S. purchase \$13,000 worth of series G Bonds (12 year bonds) in \$1000 denomination. Mr. Bowers seconded the motion and it was unanimously carried.

Releaguig for 1947-1948

Mr. Hamilton moved that effective July 1, 1947. Torrance be admitted to the C. I. F., S. S. and be assigned to the Bay League. Mr. Badenoch, as representative of the Bay League, seconded the motion and it was carried.

Mr. Hamilton announced that at their meeting of January 28, the Executive Committee admitted the Upland Branch High School. The Council accepted this action.

At the Executive Committee Meeting on January 28, a letter from Mr. C. W. Chance, Principal of Fremont Junior High School in Pomona, suggesting the possibility of organizing a League on the Junior High level in the immediate area of Pomona among the schools that have been in free lance competition for several years was discussed. The Executive Committee recommended to the Council that such a league be formed. Dr. Thompson moved that this be laid on the table until a workable plan could be arranged. Mr. S. Chester McIntosh seconded the motion and it was carried.

The Sunset League wished to be reduced to a six team league. The only feasible solution being that Santa Ana be transferred to the Citrus Belt League or that Downey be transferred to the Tri-County League. Upon investigation the Commissioner of Athletics found that both of these leagues objected to being made seven team leagues. The Commissioner of Athletics, the President of the Executive Committee and the President of the Council attended a Sunset League Meeting and made the report to the Council that the majority of the schools in the Sunset League wished to remain as they are. Therefore the Executive Committee recommended that the Sunset League remain as it is for 1947-1948. Dr. Thompson moved that the Council accept the Executive Committee's recommendations as to the Sunset

League. Mr. Buxton seconded the motion and it was carried. Mr. Davidson, representing the Sunset League, accepted the ruling but requested that the subject be brought up again next year.

Mr. David Austin of the Metropolitan League announced that the Sweetwater High School will divide and the Chula Vista High School will be formed. This will present a nine school league problem.

Mr. Stanley Shaver, Principal of Covina High School, presented another releguing question. This will be considered next year as it was presented too late for action this year.

A request from schools in the Colorado River Valley to have California high schools compete with some of the schools in Arizona and Nevada was received. Mr. Vincent Claypool, Principal of Barstow High School, stated that Barstow desires to remain in the Desert-Inyo League and at the same time wishes to participate in the Tri-State League. The Executive Committee recommended to the Council that these neighboring schools in Nevada (Boulder City and Henderson) and Arizona (Kingman and Parker) be granted passive membership into the C. I. F., S. S. upon their application so that they may compete with C. I. F. schools located on the border line. Mr. Hamilton made a motion that the Council accept this recommendation and request the State Council to conform with this action. Mr. Wright seconded the motion and it was carried.

Black Foxe Request

Mr. Hal Smelling, Swimming Coach at Black-Foxe Military Institute, requested permission to take a student to a swimming meet in Trenton, New Jersey, on March 9, 1947. The Council pointed out that there is a State-wide rule against inter-state competition. To allow the boy to compete, the Council would have to petition the State Organization to change the rule. This the Council did not wish to do, so the request was denied.

Program of Events

The Executive Committee recommended a Program of Events for the Spring Semester, 1947. The following action was taken on each event:

Wrestling: Dr. Thompson made a motion that the Preliminary Meets be officially set for March 15 at El Centro, San Diego, Mount Carmel and Sherman Institute, and the Final Meet for March 22 at El Monte. Mr. Bowers seconded the motion and it was carried.

Gymnastics: Mr. Bowers moved that the Gymnastic Meet be set for the latter part of April at Beverly Hills High School. Mr. Berlin seconded the motion and it was carried.

Tennis: Mr. Moore moved that the Class B and Class C Tournament be held April 12 & 19 at Mark Keppel High School and that the Class A Tournament be held June 7 at Mark Keppel. Mr. D. McIntosh seconded the motion and it was carried.

Track: There was a lengthy discussion in which Mr. Laurenson, Mr. Hartman, and Mr. Austin took part as to the practicability of changing the dates for the Divisional and Final Track Meets. Mr. Don McIntosh moved to reconsider the action taken on December 14, setting the date for the Divisional and Final Track Meets as May 10 and May 17. Mr. Wright seconded the motion. The motion lost by a vote of 16 to 0.

Mr. Bowers moved that the Divisional Meets on May 10 be held at San Diego, Woodrow Wilson, Compton, Riverside, and Carpinteria. Mr. Berlin seconded the motion and it was carried.

The Final Meet will be May 17 at Oxnard. The State Finals will be held May 31 at Visalia.

Swimming: Dr. Thompson moved that the swimming preliminaries be held May 7 at Anaheim and the Finals May 9 at Anaheim. Mr. McIntosh seconded the motion and it was carried.

Golf: Mr. Moore moved that the Golf Tournament be held June 6 at Montebello Park. Mr. Lawson seconded the motion and it was carried.

Basketball: The Commissioner of Athletics announced that the Basketball play-off would start March 1 and that an eight team tournament would be held March 7 & 8.

Baseball Play-off: Mr. Hamilton moved that the baseball play-off would start May 10. Mr. Buxton seconded the motion and it was carried.

Team Tennis Play-off: Mr. McIntosh moved that the team tennis play-off start May 10. Brother Edwin seconded the motion and it was carried.

Play-Off Schedules

The Executive Committee recommended that before the end of 1947 a definite play-off schedule for the 1947-1948 season be set up in all sports, in which play-off games are held. The

Commissioner of Athletics was ordered to see that such a schedule was established.

Free Lance Schedules

Santa Barbara High School submitted its basketball and team tennis schedules to the Executive Committee for approval. The Committee ruled that Santa Barbara must win 14 out of 15 basketball games in order to qualify for the play-offs. The Committee recommended that Santa Barbara win 5 out of 5 of their team tennis contests in order to qualify for the play-offs in team tennis. The Executive Committee unanimously voted to recommend to the Council that Santa Barbara qualify its boys for the Divisional Track Meet at the Ventura League Finals and that only three boys be qualified in each event from this meet. The Committee also recommended that all free lance schools must win all of their games in football and have their schedules approved in order to qualify for play-off games. Free lance schools must have their schedules approved by June 15. Mr. Harry Moore moved that the Council accept all of the Executive Committee's recommendations regarding the free lance schools and their schedules. Mr. Lawson seconded the motion and it was carried.

So as not to overload the Ventura League Meet, Mr. Buxton moved that Santa Barbara enter no more than two (2) men in any event without the permission of the Track and Field Committee. Mr. Bowers seconded the motion and it was carried.

San Diego Divisional Meet

The San Diego Track Coaches submitted the following recommendations to the Executive Committee for their approval:

1. Two days for divisional meet for San Diego & Imperial Counties. (Wednesday and Saturday).
2. Three entries in each event from each school.
3. All Entries to go to manager of Meet.
4. B & C field events to be finished Wednesday.
5. Darrell Smith of Kearny to handle meet.
6. Pole vault and high jump to be measured by steel tape from level of runway.
7. Publish marks made in each divisional meet.

The Executive Committee ruled that if all schools involved were unanimous in the request, that the Commissioner of Athletics set up the San Diego Divisional Meet in the preceding manner. The Imperial Valley Schools voted against the proposed manner of handling the Divisional Meet, so the Divisional Meet at San Diego will be run as it has been in the past.

Low Hurdle Race

The State has adopted the National Federation Regulations regarding the Low Hurdle Race. This was discussed at length at the December 14 Meeting of the Council and was put over to the February 1 Meeting for decision. To start the discussion, an informal

vote was taken as to the leagues' preferences. The Citrus Belt League and the Sunset League preferred the 220 yard hurdle. All others favored the 180 yard race. Dr. Thompson moved that the National Federation regulations of 180 yards in length with 8 hurdles, 20 yards apart in low hurdles be adopted by the C. I. F., Southern Section. Mr. Laurenson seconded the motion and it carried, 16 to 2.

Officials' Fees

Mr. Weakley asked for a clarification of the basketball officials' pay for the Imperial Valley League. For Triple-header games, the Council recommended that either three officials be used and paid \$10.00 each or two officials work all three games and be paid \$15.00 apiece.

The subject of Football Officials' Fee was tabled at the December 14 meeting and reopened by the Council on February 1. Mr. S. Chester McIntosh moved that the fees on football be a maximum of \$10.00 and in exceptional cases where unusual mileage is traveled that a 5 cents per mile for total mileage in excess of 50 miles be paid. Brother Edwin seconded the motion. On a roll call vote the motion was lost.

Mr. Carpenter made a motion that football officials be paid a maximum of \$12.00 and in unusual mileage cases that 5 cents per mile for total mileage in excess of 50 miles be paid. Mr. Lawson seconded the motion and it was carried on a roll call vote.

Baseball Bench

Mr. Laurenson moved that every baseball coach, principal and umpire be given the following safety recommendation: that the benches should be 40 feet from home plate and 30 feet from either base unless they are protected by a six (6) foot high fence. Mr. Donald McIntosh seconded the motion and it was carried.

Divisional Track Meets

Mr. Harvey Moore moved that wherever ties in time, height, or distance qualify more men than the number authorized, the men tied are to qualify for the place on the Tuesday preceding the finals or forfeit their right to the place. Mr. Weakley seconded the motion and it carried unanimously.

The Council requested the Commissioner of Athletics to edit a Special Bulletin on track rules and regulations and distribute it before the Divisional Meets.

Mr. Hartman of Compton requested that special notice be given to the regulation in the 440 yard race requiring it to be run on two (2) curves.

Mr. Hartman requested that the record of Gillette, El Centro, 48.3, 1934, in the 440 yard race be classified as "one curve" and that a "two curve" record of Duane Lewis, 49.2, Compton, 1940, be added. The Commissioner will check this record and will so designate the curves in the 440 race in the next publication of track records.

Gerald Ayers Trophy

A trophy in memory of Mr. Gerald Ayers

has been offered to the C. I. F., S. S. by his widow. This is to consist of a trophy for the school winning the one mile run in the Southern California Track and Field Meet, and a medal for the boy. Mr. Lawson moved that this trophy be accepted. Mr. Don McIntosh seconded the motion and it was unanimously carried. Dr. Thompson moved that the Executive Committee work out the details and amount of the fund for the medals with Mrs. Ayers. Mr. Weakley seconded the motion and it was carried.

Fidelity Bond

Mr. S. Chester McIntosh moved that the Treasurer's Fidelity bond be increased to \$10,000. Mr. Donald McIntosh seconded the motion and it was carried.

Competition With Los Angeles City Section

Mr. Donald McIntosh made a motion that the Commissioner of Athletics approach the Los Angeles City Section of the C. I. F. in regards to championship competition with the C. I. F., Southern Section in swimming, golf, tennis, baseball, football and team tennis. Mr. Bowers seconded the motion and it carried. The Commissioner was directed to carry out these instructions.

Mr. E. W. Oliver

Mr. E. W. Oliver, retired Principal of the Los Angeles High School and one of the founders of the C. I. F., passed away on January 19, 1947. Mr. Oliver served on the Council of the C. I. F., Southern Section from 1914 to 1935. He served on the State Council for about twenty five years. He was a true friend of high school athletics during all of his school career in Southern California. Dr. Thompson moved that a communication of sympathy be sent to Mrs. Oliver by the Commissioner of Athletics. Mr. Lawson seconded the motion and it was carried.

Spring Football Practice

Mr. Carpenter raised the problem of spring football practice. There was a lengthy discussion in which Mr. Badenoch, Mr. Carpenter, Mr. Lawson, Mr. Austin, Mr. D. McIntosh, Mr. Gorrell, Mr. Shaver, Mr. Weakley, and Mr. Moore took part. In this discussion, it was pointed out that the Insurance Premium for spring football practice alone is \$3.50.

Mr. Carpenter moved that the Council approve spring football practice only with regular gym clothes and football shoes. Mr. Weakley seconded the motion.

Mr. Launson made a motion to table the preceding motion until the next meeting. Mr. Bowers seconded the motion. On a roll call vote the original vote was tabled 11-4.

Mr. Weakley made a motion that the league representatives bring to the May Meeting of the Council a report from their leagues concerning the following:

- (1) No spring football practice.
- (2) A limited type of practice (without protective equipment other than shoes).

- (3) Unlimited type of practice (with full protective equipment).

Brother Edwin seconded the motion and it was carried. The President of the Council instructed the representatives to secure this information.

Riverside League Disturbances

Two instances of disorder following Riverside League basketball games have been reported. The Council recommended to Mr. Schafer that the League investigate and take steps to correct the situation.

Council Agenda

Mr. Lawson requested that the agenda for the Council Meeting be mailed far enough in advance that a League Meeting may be called to discuss any vital questions. The Commissioner will comply with this request.

A. D. A. Classification

Mr. Donald McIntosh asked that the Council take cognizance of the A. D. A. difference between 3 and 4 year high schools.

Mr. Moore moved that the schools be classified as to their A. D. A. figured on their 10, 11, and 12 grades and the enrollment of the non-coeducational schools be doubled. This classification list is to be used in tournaments where schools are divided according to enrollment. Mr. Lawson seconded the motion and it was carried.

Football Bye Dates

The following schools have football bye dates which they wish to fill for the 1947 football season:

El Centro, October 24; November 7.

Jordan, Long Beach, September 27; October 17.

CLASSIFICATION ERROR

When the September Bulletin was sent out, three copies of a yellow card for reckoning the Three Point Data and the exponents of boys below Class A were enclosed in the same envelope. An error was made in printing the cards, and the exponent for age was four points too low. The error was discovered two days after the cards were mailed.

The cards were corrected and reprinted at once on white cardboard and a new supply sent out with a special bulletin directing that the yellow cards be destroyed and the white cards be used.

Very recently we have been informed that some schools used the yellow cards in figuring exponents. If the yellow cards were used, the exponents for age is four points too low. If the yellow cards were used, four points must be added to the exponents for age. The C.I.F. Office will insist that all Class B & Class C track candidates be carefully rechecked before Divisional Meets.
