Carlmont High School ran and jumped a long way toward the South Peninsula Athletic League track championship by qualifying 23 varsity athletes for the finals.

The trials were held Tuesday afternoon at Sequoia High School. The finals are scheduled on the same track Saturday night.

Cold and wind prevented any top marks but the Scots still had little trouble leading the meet. They dominated the distance races with four qualifiers in the two-mile and three more in the mile.

The best marks were a 2:01.4 half-mile by Dennis Milligan of Palo Alto, a 4:34.3 mile by Mike McCann of Carlmont, a 56-51/2 by Steve Walker of Cubberley in the shot put, and a 6-3 high jump by Don Brown of Ravenswood

Cubberley qualified 18 for the finals, Palo Alto had 15 and Woodside 11.

In Class B Cubberley led with 22 qualified for the finals. San Carlos had 15.

In Class C, Elliott Kai-kee of Palo Alto set a meet record with an 8.0 clocking in the 75yard dash, and John Buckmaster of Wilbur Junior High School threw the shot 49-9.

Sequoia had the most C qualifiers - 14. Carlmont was next with nine.
