

One of your group brought up the subject of family rates as a means of reducing the air fares. On checking withour tour travel agent we find there are possible savings that were overlooked because we had considered only families of two travelling via Dallas. This is what we found:

Through fare, Wichita to Mexico City, via Dallas \$158 per person (This is the rate all of you have been charged.)

Wichita to Mexico City, via Dallas, using family plan for the Wichita-Dallas portion. (Family plan does not apply out of the country, i.e., Dallas-Mexico City.) \$158 one person \$320 two persons \$456 three persons \$592 four persons

Wichita to Mexico City, via Houston, using family plan for the Wichita-Housto portion. \$158 one person \$303 two persons \$416 three persons \$529 four persons

The price for one person is the same whether via Dallas or Houston. But on the family plan Houston becomes cheaper because more of the fare is a domestic fare and thus subject to the family plan discount.

So, please let us know an whether you wish to travel via Houston or Dallas. There is a decent connection either way. Houston is slightly cheaper for a couple and the savings are larger for the families of three and four.
