"Things have quieted down here (Sequoia) to a point where we are sure there won't be any problems Friday

night," Miller said. Meanwhile, on the track Hughes hopped, stepped and jumped 46-2 for the best mark in the County since the event was incorporated into the high school program last year.

Last week, Hughes and Carlmont's Mike Hall had both recorded County bests of 46-0.

Hall gained the second of eight qualifying berths with a leap of 45-2.

Finals will begin Friday night at Sequoia at 7 o'clock

District Prep Track Moved to Afternoon

Don't plan s'dn going to Sequoia High tonight to watch the Sequoia High School District Track and Field Finals. There won't be any runners or jumpers there.

The meet was switched from tonight to this afternoon in a move late Thursday afternoon by Sequoia Principal Robert Biggs.

Faced with a rash of fighting at his school during the week, plus the nation-wide campus unrest, Biggs felt "We

will be better able to supervise the meet during the day." "The move was precipitated

when several fights broke out at the trials Tuesday at Sequola, but the final decision wasn't made by Biggs until late Thursday. Earlier in the day, meet director Buddy Miller of Sequoia told the Tribune the meet would still be held at night.

Action began this afternoon at 2 p.m. and probably won't conclude until 6 o'clock.

Tribune Sports Writer Menlo-Atherton's Ernie Reese and Ken Murphy and San Carlos High put on a good show at the Sequoia High District Track and Field Meet Friday at Sequoia.

But very few fans were there to appreciate their efforts.

Racial violence at Sequoia High earlier in the week

forced the meet to be switched from Friday night to afternoon and it resulted in the smallest crowd in the history of the meet.

San Carlos Nabs District Track

There were no problems at the meet -, except for those competing against Reese and Murphy.

Reese won the 100 (9.9), 220 (22.2) and ran on the victorious M-A 440 relay team to share the co-track athlete of

the meet award with Murphy.

Murphy got a share of the elite honor by winning the 180 low hurdles in 19.6 —the fast-est time in the SPAL this season!

Murphy claimed an outright award when he jumped 23-9 in the long jump to win the top field athlete of the meet and move into the second spot among all-time SPAL long jumpers. Only former Sequoian Charlie Johnson has jumped further - $24-7\frac{1}{2}$ in 1967.

Both Murphy's marks were school records.

But, despite the outstanding efforts of Reese and Murphy, San Carlos' team balance was too much for the other five schools.

The Dons' Gene Davis won the high hurdles and Bill Irwin captured the discus for coach Jim Lutrell's only two first places, but SC garnered enough second, third and fourths to outscore second place M-A 77-73.

Carlmont junior Hans Templeman, out of workouts all week with the flu, won the 880 in 1:58.9 - his second best time of the season - while Scot freshman miler Steve Miller won the varsity fourlapper with his seasonal best of 4:28.5. San Carlos' Randy Lawson scratched from the field.

Sequola's Run Busch the high jump with a leap of 6-4 and junior teammate Mike Hughes carried his county-record leap of 46-2 from Wednesday's triple jump trials to Friday's finals to win that event.

Hughes added 46-0 and 46-11/2 jumps to his series Friday, but couldn't top his mark set in the trials.

Next action for District spikers will be Tuesday at Foothill College in the SPAL trials.
