--> You are expected to warm up (15 minutes brisk jog) with your team before the race and warm down (15 minutes minimum jog) with your team after the race.

--> Desiree will have your name tags. She will be located by the Coaches' Corner near the corner of the storage sheds.

Meet duties:

Since this is our invitational, we are expected to be gracious hosts and willing workers. Here are your job assignments.

PREMEET: Everyone shows up at 8:00 (or earlier) at Canyon. Everyone helps set up various areas as directed. Everyone works until at least 9:00, or until their warmup comes around.

POSTMEET: Everyone follows the directions below:

Boys' Frosh: Retrieve all cones and stack them on the concrete by the sheds.

Boys' FS: Help take down the snack bar area; gather tables and stack them on the concrete by the sheds.

Boys' JV: Help take down the chute; gather and stack stakes and flag ropes, and place by shed

Boys' Varsity: Police the area for litter after people leave; use trash sacks.

Girls' FS: Help clean up the gym after the awards.

Girls' JV: Help gather up leftover stock (T-shirts, etc.) and leftover meet materials (clipboards, stopwatches, pens, envelopes, etc.), place in appropriate boxes and load into Brewer's van.

Girls' Varsity: Help hand out awards at ceremony.




