The Houston Symphony Orchestra's October 22 Concert honored all participants of the 1983 InterFirst Symphony Run, and announced the winners in the Langham Petroleum Corporate Team Competition.

At the intermission presentation, Ellen Kelley, President of the Houston Symphony Society, was presented a gift of \$55,000 from the proceeds of the run by co-chairmen John McCutchen, II and Joanne Wilson.

The winning corporate team of the October 1, 10 kilometer race was Charles Church International. The corporate champion, whose top three finishers were Peter Buzzini, Richard Finger and Michael Ganther, had a combined time of 1:52:50. They were presented the traveling Rockwell Trophy, a sculptured artpiece by Karin Broker, named in recognition of the cultural and civic support of the Rockwell Fund, Inc.

The second place winner was First City National Bank of Houston in 1:53:52; followed by third place, Diamond Shamrock in 1:54:54; fourth place, Vinson & Elkins, 2:01:22; and fifth place, Deloitte, Haskins, & Sells, 2:05:49.

The corporate team competition was a new addition to the second annual InterFirst Symphony Run which attracted 3,000 runners. Fontaine Carroll, corporate team chairman, is pleased with the results. "We attracted 70

teams and significantly added to our proceeds. I am sure this will become an important part in next year's race which is tentatively scheduled for Saturday, September 29, 1984," she said.
