ABOUT YOUR MEMORY BOOK

Your memory book will consist of 16 pages if less than 125 sittings are photographed. A sitting may be a couple or an individual. Four additional pages are included at no charge if 125 to 149 sittings are photographed. The memory book will have 24 pages if 150 to 174 sittings are photographed.

The reunion committee may purchase extra pages at the rate of \$96.00 for each 4 pages. This is the set-up charge from the printer no matter how many copies of the book are ordered.

Your memory book may contain pages of "copy only" at NO EXTRA CHARGE.

You may, also, put a directory in the back of the book, at NO EXTRA CHARGE, as long as you stay within your allowed number of pages.

All portraits and candids taken at the reunion will be sent to the reunion committee with an easy-to-assemble materials kit. Once you complete and return these materials to "Reunions", it takes approximately 8 to 10 weeks to print the book.

If you have any questions about doing layouts for the book, even while you are working on it, please feel free to call us on the toll free numbers.

We do not collect money for the memory book at the reunion. All sales are handled by mail, following the reunion. We mail the proofs, taken at the reunion, for each member to choose which pose to be used in the book. An order form for the memory book and pictures will be included with the proofs.

You will have a choice of cover colors for your memory book. Several selections are included in the layout materials packet.

Normally black ink is used on the cover of the memory book. If any other color ink is requested, there is a charge of \$65.00 per color. Please bear in mind, that, if you choose a colored cover, you may not be able to use a colored ink. Ink changes color on colored cover stock. Example; blue ink on a yellow cover could look green.
