- 4) CCS Jobs
 - a. WBAL proposed a switch with SCVAL, they take the HJ, and we do the VG TJ. HJ has an assigned official plus 2-3 helpers, VG TJ needs 6-7 workers including the official but only half the meet. **SCVAL is passing on this option and will stick with running the HJ.**
 - b. Turn judging – SCVAL needs 2 workers for relay zone 3 for other events top of track to start of 110h/100. Must be knowledgeable about the following rules:
 - c. Relay exchanges (Rule 5-10-7, Interference (Rule 5-9), Infractions (Rule 5-13)-line violations, and Hurdling Interf. (Rule 5-14). Please review the rules. Do not want a repeat of SCVAL. Also, you are only providing information to the meet referee, he/she will make the call.
- 5) Admissions – 5 coaches only, Athletes in uniforms
 - a. No spectators for Trials, for Finals – online ticketing only
 - b. Workers are separate from the coaches' list

- 6) Other items – Field set up
 - a. Covid rules (**masks on except for competing**)
 - b. No alternates for Trials, only Finals (**geth those scratches in**)
 - c. Coach must be present (**not just parents unless they are a coach**)
 - d. Calls for event, must check in 15 minutes before scheduled time for running and field events.
 - e. No electronic devices on infield
 - f. Equipment check before competing
 - g. Athletes with running and field events at the same time (**check in early!**)
 - h. Finals Qualifying (**in PIB**)
 - i. Appeals should be made ASAP
 - j. No t-shirts but CCS has online store for patches (**\$15 for patches**)

 - a. Scratches – Alternates confirmed?

- 10) By-law change – Article VIII, Section 1 Hardship rule – update to match CCS #8, make SCVAL 1.9 the same (which means run-offs ONLY need to be in “laned” events)
Should SCVAL adopt the same hardship rule as CCS? 13-0 pass (Saratoga not present)
Should the hardship athlete be seeded into the lower (slower) heat? 13-0 passed

- 11) By-law change – Article VI, Section 6 change start time of field events from 4:30pm to earlier start? It took 2-2hrs 15minutes to complete first set of field events, currently we have 1 hr. and 45 minutes between first set and second set.
