LOCATION: Alameda Municipal Golf Course, Alameda

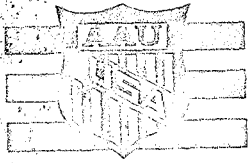
SPONSOR: Alameda Jaycees and the National Long Distance Committee-AAU
