Some team athletes at CCS did not respect the property of the home owners at the Team Bus Drop off area.

The "spread" of # of teams/runners was pretty even and met the goals of what the restructuring of divisions was meant to do.

Palo Corona may not be able to handle CCS because of parking, the size of the meet and the Spotted Frog (which can shut down the meet if seen, not kidding).

CCS is looking at returning to Toro Park but a new start line would be required if they don't repair the starting field. Others stated that the original start field has been repaired. CCS will look into.

Would like to go back to Toro – CCS would decide by mid to late January of 2024 where CCS meet would be.

When will the new team allotments be figured out? By June 1<sup>st</sup> at the latest.

Why does CCS not follow the State time schedule? At Crystal, it's so that teams will come in, race, and then leave due to parking constraints at the site.
